5.	Other Govt. Organisation who visit Institute for Official Meeting (A.C Room)	Rs. 500/- per day
6.	Other Govt. Organisation who visit Institute for Non Official Meeting (Normal Room)	Rs. 600/- per day
7.	Other Govt. Organisation who visit Institute for Non Official Meeting (A.C Room)	Rs. 750/- per day
